

Information clause for a Mathematics in Focus Competition participants

In accordance with art. 13 (1) and (2) of General Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (GDPR), and the Act of 10th May 2018 on the protection of personal data (Journal of Laws of 2018, item 1000, as amended)

1. Your personal data is administered by:

1) The University of Szczecin (the Controller), with the headquarters in Szczecin, at al. Papieża Jana Pawła II 22a, Poland, called US or the Jonit Controller

and

2) The Maria Grzegorzewska University with the headquarters in Warszawa, at ul. Szczęśliwicka 40, Poland, called APS or the Joint Controller

2. The administrators concluded an agreement on co-administration of personal data of the Participants of the Mathematics in Focus Competition (hereinafter: the Competition) in the scope of organizing and promoting the Competition.

Under the joint control agreement, the scope of responsibility regarding the fulfillment of obligations under the GDPR was agreed, in particular, it was agreed that the US and APS jointly will be responsible for meeting the information obligation towards the Participants of the Competition and for enabling its Participants to exercise their rights under the GDPR in the field of personal data processing referred to in paragraph 13.

3. Each of the Joint Controllers, to the extent that it processes personal data on its own, will be obliged to verify the adequacy and correctness of the data collected as part of joint processing activities. Regardless of the above division of duties, each of the Joint Controllers is equally responsible for the proper and lawful processing of personal data of Competition Participants.

4. .US has appointed Anna Giedrys as a data protection officer to supervise the correctness of personal data processing, who can be contacted at this e-mail address: iod@usz.edu.pl;

5. APS has appointed Piotr Grzybowski as a data protection officer to supervise the correctness of personal data processing, who can be contacted at this e-mail address: pg@aps.edu.pl

The Joint Controllers agreed that all questions related to the processing of personal data should be directed to the e-mail address of the Data Protection Officer of the University of Szczecin, which has been specified as the contact point for persons whose data is processed. Notwithstanding the above arrangements, the data subject may exercise his or her rights under the GDPR towards each of the Joint Controllers. The above results from Art. 26 sec. 3 GDPR.

6. The personal data of the Competition Participants will be processed in order to conduct, organize and promote the Mathematics in Focus Competition.

7. Personal data is collected on the basis of consent, in accordance with art. 6 section 1 letter a of the GDPR for the purposes of organizing, conducting and promoting the Competition and publishing information about the winners of the Competition.

8. Providing by the Participants of the Competition personal data necessary to perform the tasks referred to above is not mandatory, but necessary to participate in competition.

Providing additional data is voluntary.

9. The Joint Controllers process the personal data of the Competition Participants in a strictly defined, minimum scope.
10. The personal data of the winners of the competition may be transferred to the founders of the prizes in order to fulfill the formal requirements related to receiving the prizes and/or to postal service providers in order to deliver the prize.
11. The Joint Controllers may transfer/entrust data of Competition Participants to other institutions/entities.
The basis for the transfer/entrustment of data are the provisions of law or data processing agreements concluded with entities providing services to the Joint Controllers.
The recipient of personal data will be entities authorized under the law or entities providing services to the Joint Controllers on the basis of separate agreements.
12. Personal data processed by the Joint Controllers will be stored for the period necessary to achieve the purpose for which they were collected.

Personal data will be stored in accordance with the requirements of the Act of 14 July 1983 on national archival resources and archives for the period specified in these regulations.
13. The participant whose personal data relates has the right to access his data and receive a copy thereof, rectify it, delete it, limit processing, as well as object to data processing
14. The data subject/the participant has the right to lodge a complaint with the President of the Office for Personal Data Protection (to the address: Office for Personal Data Protection, ul. Stawki 2, 00-193 Warsaw).
15. The participant whose personal data relates has the right to withdraw consent at any time. Withdrawal of consent, however, will not affect the processing that was carried out on the basis of that person's consent before its withdrawal.
16. The Joint Controllers do not process the personal data of Competition Participants in an automated manner.
